
To put into practice an effective and sustainable HTA collaboration in Europe that brings added value at the European, national and regional level



#### EUnetHTA Joint Action 2010-12

#### Focus on HTA in Europe to

- facilitate efficient use of resources available for HTA,
- create a sustainable system of HTA knowledge sharing, and
- promote good practice in HTA methods and processes
- Budget: € 5.959.525

## Orientation on the EUnetHTA JA2 proposal (2012-15)

- Proposal submitted May 23, 2011
- Official title "EUnetHTA JA2"
- 37 APs from 26 MS, Norway, Croatia
- 15 CPs (currently)
- Proposed JA2 timing: October 2012-Sept 2015
- Budget € 9.428.550



#### **Objectives of the EUnetHTA JA2**

#### General Objective

The general objective of this complimentary Joint Action on Health Technology Assessment (JA2) is to strengthen the practical application of tools and approaches to cross-border HTA collaboration. The JA2 aims at bringing collaboration to a higher level resulting in better understanding for the Commission and Member States (MS) of the ways to establish a sustainable structure for HTA in the EU.

Specifically, the JA2 will develop a general strategy, principles and an implementation proposal for a sustainable European HTA collaboration according to the requirements of Article 15 of the Directive for cross-border healthcare.



#### EUnetHTA JA2 WP 7 Specific objectives

Develop and test a methodological basis for European cooperation on HTA including guidelines for distinct methodological issues and quality improvement of evidence generation for HTA



#### EUnetHTA JA2 WP 7 Specific objectives

#### Develop

- methodological guidelines on pertinent issues of assessment (e.g. for devices) or update existing guidelines according to needs and resources
- guidelines for improving evidence generation in early dialog with manufacturers
- a uniform data template for submissions enabling sound, common rapid assessments and national adaptation

#### Work in JA 2 WP 7

 Tools (guidelines and templates) will be developed on the basis of the HTA Core Model to facilitate and help standardizing technology developers' data files for submissions of dossiers for rapid HTAs (standardizing the presentation of data, completeness of submitted data)

#### Work in JA 2 WP 7

• New developments to improve the robustness and efficiency of HTA comprise actions and measures to support and guide the generation of higher quality and more appropriate evidence for initial assessment "upstream" in the technology "pipeline" where innovations undergo research and development before introduction to healthcare practice






- AE = Assessment element
